Professional Gardening and Landscaping Maintenance Services

The Embassy of the Republic of the Philippines in Amman is inviting qualified professional service providers to submit service/price quotations for PROFESSIONAL GARDENING AND LANDSCAPING MAINTENANCE SERVICES for a contract period of one (1) year from 01 January to 31 December 2024.

The following minimum requirements and scope of work include, but not limited to the following:

1. Complete gardening, horticultural and landscaping maintenance & enhancement services, to include the following:
 - a. Cover a total garden/lawn area of 500 sqm (approximate)
 - b. Supply all necessary tools, equipment and materials to be used on-site
 - c. Proper irrigation, propagation, weeding, mowing, reseeding, cultivation and cleaning of the entire garden, including all the flora and soil in the garden, lawn and perimeter/fence (approx. 110 meters) areas.
 - d. Trim, prune, shape and groom all plants, trees, shrubs and all other flora
 - e. Provide and apply regularly appropriate fertilizers, pesticides, fungicides, soil and soil enhancer and other growing media to manage proper garden health and all types of pests and diseases
 - f. Replant, restock and enhance overall garden design and layout, including all potted and on ground garden materials, irrigation and lighting systems
 - g. Dispose all yard waste appropriately after every service schedule
2. Minimum of three (3) scheduled onsite visits per week by one (1) professional and uniformed gardener
3. Scheduled monthly onsite visit/consultation by a agricultural engineer or manager
4. Contract will be subject to termination or renegotiation on either party by giving one-month advance notice
5. Authorized Signatory: **Wilfredo C. Santos**

6. Quoted price should be in Jordanian Dinar and should include all applicable taxes, duties and/or levies payable; and
7. Bidders should accept a send-bill payment arrangement every end of the month.


